Launched in April 2025, CSI already includes 10 certified fisheries landing 3 million metric tonnes, thanks to the successful integration of the Responsible Fisheries Management (RFM) program. Our global governing board includes representatives from Canada, the Caribbean, Japan, New Zealand, South Africa, Mexico, the United Kingdom and the United States. More fisheries globally are preparing to certify, with strong demand across the supply chain.

CSI certifies against a Fishery Standard grounded in the UN FAO's Code of Conduct and Ecolabelling Guidelines, ensuring global consistency and credibility. No conditional certifications. Just clear expectations and proven management. Our Unified Chain of Custody Standard ensures full traceability, drawing on the trusted framework previously applied by the RFM and Iceland Responsible Fisheries programs.

CSI is governed by a diverse, experienced board and supported by two expert committees overseeing the Fishery and Chain of Custody standards. As a non-profit (U.S. 501c pending), we are mission-driven, not profit-driven—prioritizing ocean conservation while recognizing the needs of the seafood sector.
